NOVA Hope for Haiti provides medical care to the community of Cavaillon, located in Southwest Haiti. NOVA accomplishes this by owning and operating a medical clinic on 12 acres of property. NOVA Hope for Haiti completed the construction of a new clinic following the 2021 earthquake which severely damaged our first medical clinic building. Our new clinic opened in January 2024 and includes five exam rooms, pharmacy and laboratory. Our separate residence building that can house 12 visiting volunteers also has a full kitchen and communal area. NOVA Hope for Haiti's only paid staff is one Country Head and our Haitian medical team (two doctors, five nurses, pharmacist, lab technician) and support staff (maintenance and security). All US members of the NOVA Hope for Haiti Board and committees are volunteers. NOVA Hope for Haiti treats approximately 9,000 patients per year.
